

General Conditions

- The GNSS Receiver module L76-L (manufacturer Quectel Wireless Soluations Co., Ltd.), which is incorporated in the product, has not been part of the assessment; the module already has received the RED Module-B (certificate number: RE-17062707) from Notified Body Siemic Milpitas USA (NB nr.:2200).

The module RF compliance standards, which are shown on the Module certificates, have been copied into this certificate.
